Emgold Mining Corporation (EMR – TSX Venture Exchange) (the "Company" or "Emgold") is generating opportunity for our stakeholders by developing the Idaho-Maryland Gold Mine, located in Grass Valley, CA. The Idaho-Maryland Mine is historically the second largest underground gold mine in California, producing 2.4 million ounces. The Idaho-Maryland Project (I-M Project) contains a NI 43-101 compliant gold resource (472,000 measured and indicated ounces and 1,002,000 inferred ounces). Emgold is now in the final phase of permitting with the Draft Environmental Impact Report ("DEIR"), expected to be completed in October 2008, and the Final Environmental Impact Report ("FEIR") expected to be completed in Q1 of 2009.
